The Viking Microfast® Quick Response Fusible Element Horizontal Sidewall Sprinkler VK307 is a small thermosensitive solder link spray sprinkler available with various finishes and temperature ratings to meet design requirements. The special Polyester and Polytetrafluoroethylene (PTFE) coatings can be used in decorative applications where colors are desired.



Order Quick Response Horizontal Sidewall Fusible Element Sprinkler VK307 by first adding the appropriate suffix for the sprinkler finish and then the appropriate suffix for the temperature rating to the sprinkler base part number.

Finish Suffix: Brass = A, Chrome = F, White Polyester = M-/W, Black Polyester = M-/B, and Black PTFE = N

Temperature Suffix: $165 \,^{\circ}\text{F} / 74 \,^{\circ}\text{C} = \text{C}$, $205 \,^{\circ}\text{F} / 96 \,^{\circ}\text{C} = \text{E}$, and $280 \,^{\circ}\text{F} / 138 \,^{\circ}\text{C} = \text{G}$

For example, sprinkler VK307 with a Brass finish and a 165 °F / 74 °C temperature rating = Part No. 13947AC

During fire conditions, the heat-sensitive fusible element assembly disengages, releasing the seat and spring assemblies to open the waterway. Water flowing through the sprinkler orifice strikes the sprinkler deflector, forming a uniform spray pattern to extinguish or control the fire.





cULus Listing Requirements:

Quick Response Horizontal Sprinkler VK307 is cULus Listed as indicated in the Approval Chart for installation in accordance with the latest edition of NFPA 13 for sidewall standard spray sprinklers.

- Sprinkler VK307 is limited to Light Hazard occupancies only.
- · Locate Sprinkler VK307 with the deflector 6" to 12" (152 mm to 305 mm) below the ceiling.
- · Protection areas and maximum spacing shall be in accordance with the tables provided in NFPA 13.
- · Minimum spacing allowed is 6 ft. (1.8 m).
- Align the top of the deflector parallel with the ceiling.
- · Locate no less than 4" (102 mm) from end walls.
- Maximum distance from end walls shall be no more than one-half of the allowable distance between sprinklers. The distance shall be measured perpendicular to the wall.
- The sprinkler installation and obstruction rules contained in NFPA 13 for sidewall standard spray sprinklers must be followed.




